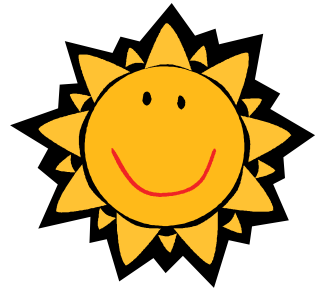


## Little Flower Catholic School Summer Camp 2010
